## Continuous Programming Workflow

### CONTINUOUS PROGRAMMING

e.g. Continuing Drama / Ongoing Series with no break between series or seasons.

To ensure a continuous programme is able to remain certified and therefore able to use the albert logo on their end board, we require that a Carbon Footprint and Carbon Action Plan is completed to cover a 12-month period from the date of preapproval. The production then must recertify each year in order to continue to display the logo. *(The 12-month period does not have to be January - December)*

Year on year we would expect to be able to see a clear reduction in carbon emissions over time.

Year 1 Requirement	Info
Draft Carbon Footprint	Completed and submitted in Pre-Production.
Carbon Action Plan	Submitted in Pre-Production.
<b>The production at this stage MUST identify themselves as a continuous programme in the notification section.</b>	
60% of CAP Evidence	If you can provide 60% of the required evidence, demonstrating your sustainable efforts we can pro-approve the use of the logo. This can include planning documents.
Remaining 40% of CAP evidence	This will need to be submitted 4 weeks before the end of year 1.
Complete Carbon Footprint	This will need to be submitted 4 weeks before the end of year 1.

**The status of the Carbon Footprint and Carbon Action Plan must be 'COMPLETE' by the end of the year. If not it will result in the following year being unable to display the logo until this is resolved.**

Subsequent Year/s	Info
Draft Carbon Footprint	Submitted 4 weeks before the new year starts to account for cross over periods between years. <i>This will help to reduce the chance of having a gap in approval for logo use between the 2 years.</i>
Carbon Action Plan	Submitted 4 weeks before the new year starts to account for cross over periods between years. <i>This will help to reduce the chance of having a gap in approval for logo use between the 2 years.</i>
<b>The production at this stage MUST identify themselves as a continuous programme in the notification section.</b>	
60% of CAP Evidence	Submitted at least 4 Weeks before the new year starts to account for cross over periods between years.  If you can provide 60% of the required evidence, demonstrating your sustainable efforts we can pro-approve the use of the logo.

**The above is on the understanding that the previous year MUST complete. Failure to do so will result in approval to use the logo being removed and certification revoked until such time that it can be reinstated.**
